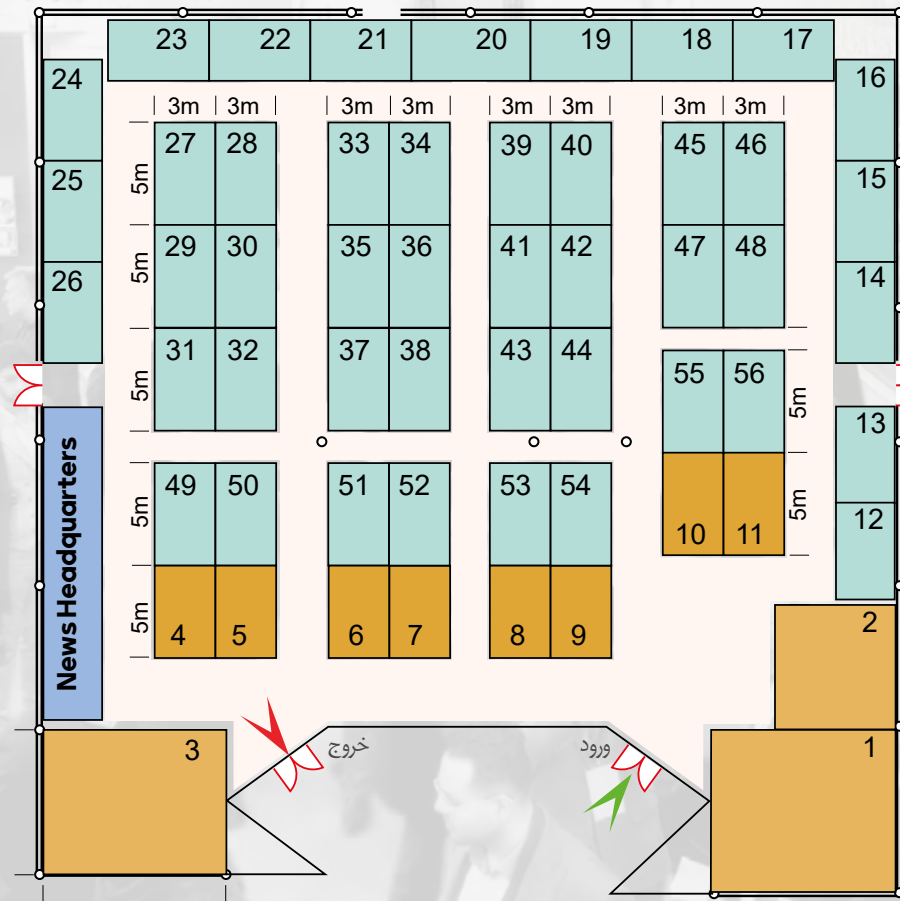
- Obtaining stands comes with a package of additional services.

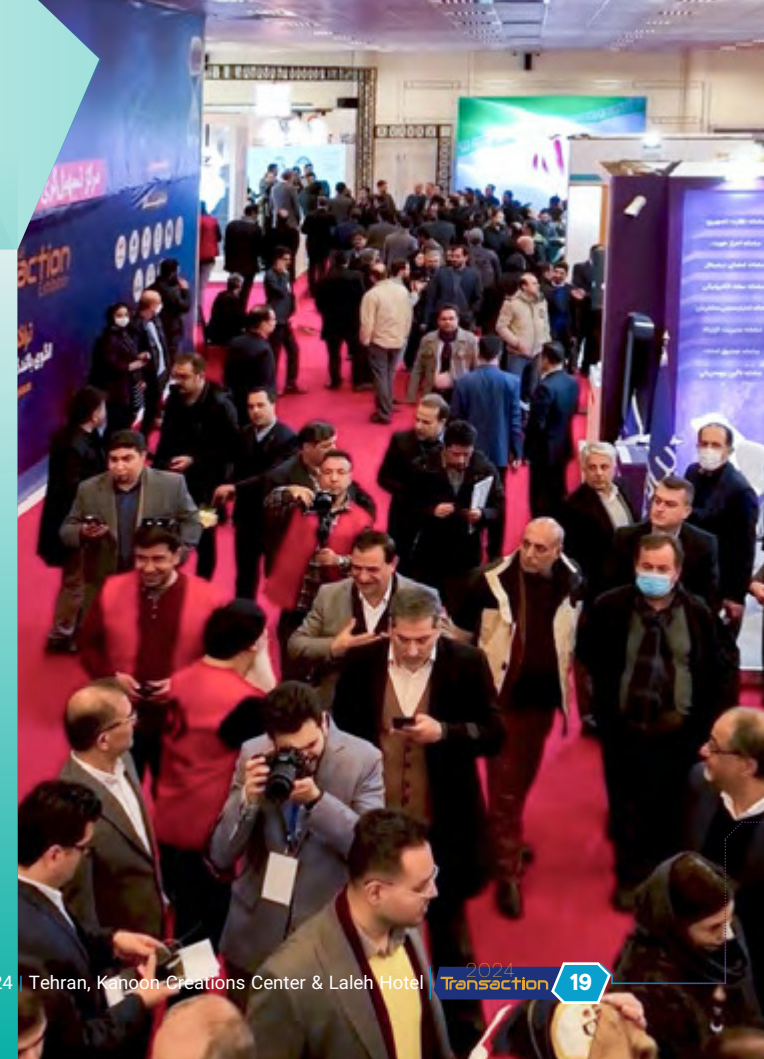

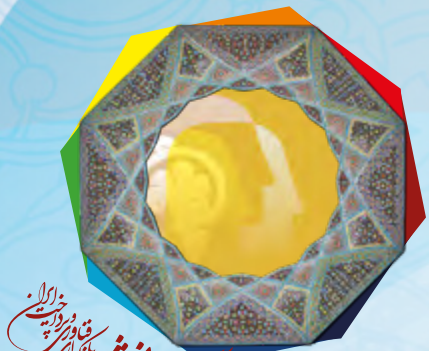

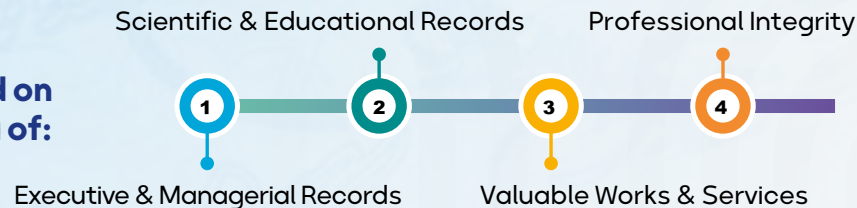

- The owners of each of the top products have one hour to explain their product in the presence of enthusiasts and journalists on the 9th and 10th of January.

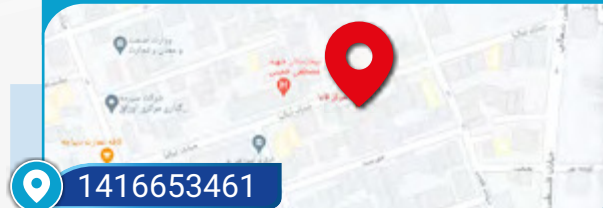
